## It's **SUMMER FUNSHINE** with **GIRL SCOUTS!**



Girl Scouting is here all year long. Keep the fun, friends, laughter and learning going all summer long. **SUMMER FUNSHINE** provides an opportunity to do some things your troop didn't have the time or resources to do during the school year, and is an excellent opportunity to introduce bridging Girl Scouts to the rest of the girls in the troop. **It's the perfect answer to the summer boredom blues!**

To earn the **SUMMER FUNSHINE** patch or bar, troops must complete the following requirements:

1. Participate in **three** activities (one per month) during June, July, and August. Your activities *must* include:
  - a) **Community service project** (e.g. make masks, make cards for seniors in assisted care or participate in the **GSSEF Summer Infant Supply Drive** or **Feeding Florida Together Food Drive**).
  - b) **Girl Scouts @ Home activity** (e.g. Badge Blueprints, council sponsored virtual program).
  - c) **Troop choice activity** (e.g. work towards a new badge, start a Journey or participate in a GSSEF-sponsored virtual program together).
2. It is not necessary for every girl to participate in each activity, but each girl must participate in at least one activity to be eligible for the patch/bar.
