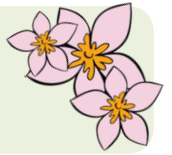




## 2020 Fall Product Program Permission Form

No product program material will be distributed until this authorization has been signed and returned.

The purpose of the Fall Product Program is to teach girls to work as a team, set goals and strive to achieve them, handle and account for money, and develop sales and marketing skills. The money earned supports troop activities and other program services and opportunities throughout Girl Scouts of Southeast Florida, following the guidelines established in our council's Policies and Procedures. Girl Scouts can participate in the 2020 Fall Product Program in several ways as described in this Family Guide including online nut and candy, online magazine, paper order card nut and candy, Hometown Heroes care package, and Save Around coupon book sales. *Please review the information below, before signing this form:*

- I understand that the girls are encouraged to participate in the online nut and candy, and magazine order process **starting on September 1, 2020.**
- Orders for nuts and candy, care packages, and coupon books from the paper order card may not be taken before October 1, 2020.
- I understand that I must provide adult supervision of my girl's participation in the Fall Product Program at all times.
- I understand that items for sale during the Fall Product Program **may not be advertised or sold** through online auction or sale websites such as eBay, Craigslist, Facebook pages, or other community sites.
- I agree to follow all safety procedures as explained by my Girl Scout's Troop Leader or other representative. This includes sales conducted both in-person and online. For details, please refer to the safety activity standards which can be found in the council's Policies and Procedures.
- I have reviewed and agree to follow the money handling instructions as outlined in this Family Guide.
- I agree to accept responsibility for all nuts and candy, magazine, care package, and coupon book orders, and money my Girl Scout receives. I agree to assist her in making prompt deliveries and collecting payments for the nuts and candy, care packages, and coupon books. I understand that money collected by my Girl Scout belongs to Girl Scouts of Southeast Florida. In the event of non-payment for nut and candy orders, magazine orders, care package orders, or Save Around coupon book orders received, I understand that Girl Scouts of Southeast Florida reserves the right to initiate collection procedures by its designated agent on delinquent funds.
- I understand that all rewards shown here are based on an individual girl's sale as recorded until November 15, 2020.
- I understand that nut and candy items and coupon books received **MAY NOT** be returned.
